**CONTEST**

**for enrolment of students for Postgraduate Specialist Study Programme in Criminal Investigation at the University of Rijeka ( hereinafter: the Study ) with duration of three semesters.**

Classes will be held in **Rijeka**.

Upon the completion of the Study, the student acquires a degree of **university specialist in criminal investigation (univ.spec.crim.)**.

**1. Conditions for enrolment**

Applicants who have completed undergraduate 4-year study programmes are eligible for enrolment.

**2. Conditions of entry**

- a) Law graduates, i.e. Masters of Law and criminalistics graduates, i.e. Masters of Criminalistics, enrol without having to meet any special requirements.
- b) Applicants who have completed undergraduate or graduate study programmes of economics, political science, sociology, psychology, history, ethnology, education and rehabilitation sciences, transport and traffic sciences or other study programmes involving at least two law courses have to meet special requirements before taking exams at the Study, and that is to complete exams in Criminal Law and Criminal Procedure Law.
- c) Applicants who did not complete exams in at least two law courses have to meet special requirements before taking exams at the Study, and that is to complete exams in Constitutional Law, Criminal Law and Criminal Procedure Law.
- d) Students from b) and c) have to complete the exams in agreement with the Head of the Study.
- e) All applicants are required to know one of the main foreign languages, at the level as to be able to follow lectures, professional literature and the basics of professional communication. The knowledge of a language is, if needed, tested, the testing of which is established by the Council upon the proposal of the Head.

**3. The admission is a maximum of 40 students.**

**4. Tuition fee and exam fees**

Tuition fee amounts 1000 EUR per semester ( first and second semester ). Tuition fee for the third semester amounts to 800 EUR. Tuition fee can be paid in Croatian Kuna or other currency, having in mind that the sum has to correspond to the amount of 1000 EUR based on the middle exchange rate of CPB on the day of payment. Student has to enclose confirmation of the payment when applying to the Study. Payments have to be made at the bank account University of Rijeka: IBAN: HR8023600001101322186, reference number: OIB of the student from the Republic of Croatia or personal identification number of the student from abroad. Description of payments is : tuition fee for PDSS K.I. – first and last name of the student and/or payment for exams ( name the exams and first and last name of the student ). Installment payments are not available for the first semester. Exam fee amounts 300, 00 Croatian Kuna/exam. This amount has to be paid before taking the exams. There are no refunds.

**5. Deadlines for application**

Applications have to be submitted by January 12<sup>th</sup> 2015 to the University of Rijeka, Trg braće Mažuranića 10, HR 51000 Rijeka ( n/r gđe Ana Tomaško Obradović ) with note "Za upis na PDSS Kriminalističko istraživanje" ( For enrolment to the Study ).

Classes will be usually held on Saturdays.

It is mandatory to enclose the following:

- original or a certified copy of a degree or a certificate of completed studies,
- transcript of courses and grades achieved throughout the study and
- certificate of employment ( if candidate is employed ).

List of enrolled students will be published on a bulletin board of the University, as well as on the website [www.uniri.hr](http://www.uniri.hr) by February 1<sup>st</sup> 2015.
